RA 8293 as amended by RA 10372

- -Sec. 183 Designation of Societies
- -Sec. 185 Fair Use
- -Sec. 230 IP Policies in relation to licensing agreements with a CMO



IP Code as amended

 The owners of copyright and related rights or their heirs may designate a society of artists, writers, composers and other right-holders to collectively manage their economic or moral rights on their behalf. (Sec. 183)



FILCOLS as an accredited CMO

 To collectively administer, license, and enforce the right of reproduction (Sec. 177.1, IP Code) of authors, publishers, and other right holders in the text and image sector.

- Represents local authors and publishers (rightsholders)
- Represents international authors and publishers through bilateral agreements
- One-stop shop for licensing, distribution



RRO

- RRO provides copyright permissions or license for large-scale photocopying or reprographic reproduction (and digital re-use depending on the mandate)
- 143 members from 79 countries
- International Federation of Reproduction Rights Organizations (IFRRO)

Content

- Copyrighted works: Local and foreign
- FILCOLS members: author, publisher, heir

- Public domain
- Fair Use



Content

Copy (or reproduce) from original work

- Cover
- Table of contents
- Exercises
- Guide questions
- References: title, author, publisher



Journals and Newspapers:

 no more than one article from any issue, unless the articles relate to the same subject matter, in which case all those articles may be copied

• E.g. EJKs



Artistic Works:

 any artistic work that accompanies or illustrates the copied text

• E.g. Chart, graph, diagram, drawing, cartoon or picture



Anthologies:

• the greater of 15% of the pages or an entire single short story, essay, article or poem

- E.g. The Mats by National Artist F. Arcellana,
- Gymnast by Enrique S. Villasis



Reference works (encyclopedia, dictionaries, annotated bibliographies):

 the greater of 10% of the pages or an entire entry



Any other work including books:

New edition:

the lesser of one chapter or 20% of the number of pages of the work

• Out of print:

100%
